Privacy Policy

Introduction.

This Privacy Policy outlines Cinema Entertainment Corp.'s ("we," "our," "us," or the "Company"), and its subsidiaries' and affiliates', practices with respect to information collected from users who access our website (collectively "Users," "you," or "your") at https://www.cectheatres.com/ (the "Site"), or otherwise share personal information (meaning, any information which may potentially allow your identification with reasonable means; hereinafter "Personal Information") with us. This Privacy Policy is designed to assist you in understanding how we collect, use, share, and safeguard your information. Capitalized terms used but not defined in this Privacy Policy have the meanings given to them in the Terms and Conditions of Use found on the Site.

What Information We Collect and How we Collect it.

The information we collect varies based on how you interact with us, which services you use, and the choices you make. We collect and process information about you as necessary to provide the services you use, operate our business, meet our service and legal obligations, protect the security of our systems and Users, or fulfill other legitimate interests.

We receive information, including your Personal Information, from various sources:

- When you voluntarily provide us your personal details on our Site;
- When you use or access our Site in connection with your use of our services;
- From third party providers, services, and public registers (for example, Site traffic analytics vendors).

We collect different types of data and information from Users. The first type of information is unidentified and non-identifiable information pertaining to a User(s), which may be made available or gathered via your use of the Site ("Non-personal Information"). We are not aware of the identity of a User from which the Non-personal Information was collected. Non-personal Information which is being collected may include your aggregated usage information and technical information transmitted by your device, including certain software and hardware information (e.g. the type of browser and operating system your device uses, language preference, access time, etc.) in order to enhance the functionality of our Site. We may also collect information on your activity on the Site (e.g. pages viewed, online browsing, clicks, actions, etc.).

Another type of information is Personal Information which is individually identifiable information, namely information that identifies an individual or may with reasonable effort identify an individual. Such information includes:

• Personally Identifiable Information, such as name, address, email address, and phone number.

We also collect device information from your device, some of which may be Personal Information. Such information includes geolocation data, IP address, unique identifiers (e.g. Media Access Control address and Universal Unique Identifiers) and other information which relates to your activity through the Site.

Additionally, we may use the information, including your Personal Information, for the following:

- Providing you with marketing offers and promotional materials related to our Site and services; or
- Performing research, technical diagnostics, or analytics.

We may also disclose information if we have good faith to believe that disclosure of such information is helpful or reasonably necessary to: (i) comply with any applicable law, regulation, legal process or governmental request; (ii) enforce our policies (including our Terms of Service and Use), including investigations of potential violations thereof; (iii) investigate, detect, prevent, or take action regarding illegal activities or other wrongdoing, suspected fraud or security issues; (iv) to establish or exercise our rights to defend against legal claims; (v) prevent harm to the rights, property or safety of us, our users, yourself or any third party; or (vi) for the purpose of collaborating with law enforcement agencies and/or in case we find it necessary in order to enforce intellectual property or other legal rights.

How We Keep Your Personal Information Secure.

We have implemented and maintain reasonable administrative and technical safeguards designed to protect your Personal Information from unauthorized access, disclosure, use, and modification. Please be aware that, although we strive to keep your Personal Information secure, no security measures are absolute, the internet is not a secure medium and it may be inherently unreliable and subject to interruption or disruption and may be subject to inadvertent or deliberate breaches of security. Use caution when transmitting Personal Information over the internet.

User Rights.

You may request to:

• Receive confirmation as to whether or not personal information concerning you is being processed, and access your stored Personal Information, together with supplementary

information. You may request a report about the Personal Information that is collected, how it is collected, reasons for its collection, and with whom the information is shared or sold for the prior 12 months.

- Receive a copy of Personal Information you directly volunteer to us in a structured, commonly used and machine-readable format.
- Request rectification of your personal information that is in our control. This includes correcting inaccurate Personal information that we have; you can correct the information by sending us the correct information, or may request us to correct it for you.
- Request erasure of your Personal Information that we have in our control.
- Object to the processing of Personal Information by us.
- Request to restrict processing of your Personal Information by us.
- Lodge a complaint with a supervisory authority.
- Opt-out of the selling or sharing of your Personal Information.
- Limit the use and disclosure of sensitive Personal Information collected by us about you to only those uses and disclosures required for us to provide the services.

However, please note that these rights are not absolute, and may be subject to our own legitimate interests and regulatory requirements, unless otherwise restricted by law.

European Data Protection; Scope of Services.

We are located in the United States and do not provide services outside of the United States. The Site and our services are not permitted for use by anyone that is living outside of the United States.

Retention.

We will retain your information, including your Personal Information for as long as necessary to provide our services, and as necessary to comply with our legal obligations, resolve disputes, and enforce our policies. Retention periods will be determined taking into account the type of information that is collected and the purpose for which it is collected, bearing in mind the requirements applicable to the situation and the need to destroy outdated, unused information at the earliest reasonable time. Under applicable regulations, we will keep records containing client personal data, account opening documents, communications and anything else as required by applicable laws and regulations.

We may rectify, replenish or remove incomplete or inaccurate information, at any time and at our own discretion.

Cookies.

We and our trusted third-party providers use cookies and other technologies in our related services, including when you visit our Site or access our services. A "Cookie" is a small piece of information that a website assigns to your device while you are viewing a website. Cookies are very helpful and can be used for various different purposes. These purposes include allowing you to navigate between pages efficiently, enable automatic activation of certain features, remembering your

preferences and making the interaction between you and our Services quicker and easier. Cookies are also used to help ensure that the advertisements you see are relevant to you and your interests and to compile statistical data on your use of our Services.

The Site may use the following types of cookies:

- 'session cookies' which are stored only temporarily during a browsing session in order to allow normal use of the system and are deleted from your device when the browser is closed;
- 'persistent cookies' which are read only by the Site, saved on your computer for a fixed period and are not deleted when the browser is closed. Such cookies are used where we need to know who you are for repeat visits, for example to allow us to store your preferences for the next sign-in;
- 'third party cookies' which are set by other online services who run content on the page you are viewing, for example by third party analytics companies who monitor and analyze our web access.

Cookies do not contain any information that personally identifies you, but Personal Information that we store about you may be linked, by us, to the information stored in and obtained from cookies. You may remove the cookies by following the instructions of your device preferences; however, if you choose to disable cookies, some features of our Site may not operate properly and your online experience may be limited. We also use a tool called "Google Analytics" to collect information about your use of the Site. Google Analytics collects information such as how often users access the Site, what pages they visit when they do so, etc. We use the information we get from Google Analytics only to improve our Site and services. We do not combine the information collected through the use of Google Analytics with personally identifiable information. Google's ability to use and share information collected by Google Analytics about your visits to this Site is restricted by the Google Analytics Terms of Use and the Google Privacy Policy. Third party collection of information.

Our Privacy Policy only addresses the use and disclosure of information we collect from you. Accordingly, when you leave our Site we encourage you to read the terms and conditions and privacy policy of each third party that you choose to disclose information to. This Privacy Policy does not apply to the practices of companies that we do not own or control, or to individuals whom we do not employ or manage, including any of the third parties which we may disclose information as set forth in this Privacy Policy.

Location of Your Information.

The information we collect may be stored and processed in your region, in the United States, or in any other country where we or our affiliates, subsidiaries, or service providers maintain facilities. We take steps designed to ensure that the information we collect under this statement is processed according to the provisions of this statement and applicable law wherever the information is located.

Advertisements.

We may use a third-party advertising technology to serve advertisements when you access the Site. This technology uses your information with regards to your use of the services we provide to serve advertisements to you (e.g., by placing third-party cookies on your web browser).
